Prior to the meeting, members will have received a copy of the Resolution to be tabled regarding the Commons Act 2006 and Commons Councils. Below is an extract of the draft Minutes of the meeting which covers the relevant discussion:

The Yateley Society 26th Annual General Meeting held on Thursday 15 February 2007



Peter Tipton explained that the Act of Parliament has been passed but implementation of the part concerned with Statutory Commons Councils will require regulations from the ministry, which are not now expected to be published until late in 2008. There were several problems with the 1965 Registration Act which are now addressed in the new Act.

The Commons Councils are intended to solve problems of overgrazing in large areas like the Pennines and the Lake District, and the Act addresses agricultural issues. In the South the issues are recreation, nature conservation and biodiversity, and under-grazing.

Those parts of the Common that are owned by the HCC and are managed currently have 'unfavourable declining' status. The MOD part is 'unfavourable recovering'. Other parts of the common are not managed; the proposed Commons Council would include them all within its scope, irrespective of ownership.

SQ asked how many commoners there are. There were only 23 properties registered for the Yateley Common because many people were put off registering in 1965-69 by the threat of legal costs. Yateley Green and surrounding area is also common land. It is possible that there are commoners who do not know their status. The new act allows for creation of commoners.

MM noted that if we don't have a Commons Council the current management will continue on the County part, except that the HCC no longer has a committee structure and the status of the Commons Management committee will change.

RS stated that grazing would only be possible if roads were fenced. Peter Tipton replied that the new Act allows for light works to be authorised by Commons Councils without the consent of the Secretary of State. The Commons Council would be able to approve fencing for grazing. Adjacent landowners are required to fence against the common at their expense so the cost of new fencing required by roads would probably fall on the public purse.

TH speculated that the former Eversley Common could be restored to common land.

MM asked about enforcement powers for the Commons Council. These are not yet defined. Peter Tipton promised to take this up with DEFRA.

Peter Tipton has been asked by DEFRA to write an 'issues' paper concerning the whole of Yateley Common from his 30 years experience..

FH was concerned that the costs would fall on local people. Peter Tipton explained that there may be European money possibly from the CAP that only Commons Councils can apply for.

PT asked whether the burdens on landowners would be too high so they would seek to dispose of land rather than maintain it. Peter Tipton thought the Commons Councils may not be allowed to become landowners, but promised to take this up with DEFRA.

GB asked why we needed the resolution to ask for a public meeting, could we not just call a meeting. It was thought that it would not be appropriate to call the meeting until the regulations are much clearer. The resolution would inform recipients of our interest and the resolution laid out the process that would have to be undertaken to obtain a Commons Council.

Peter Tipton stated his legal interest as a commoner, and asked permission from the Chairman to be able to vote for the resolution, which was granted.

The resolution was passed unanimously!

Since the meeting we have heard that Defra are to visit Yateley later this month – watch this space!

Family History Corner - Henry Broad - Part Three

(from the family history narrative compiled by Godfrey H. Broad November 2006 about Henry Broad, schoolmaster of Yateley School 30 December 1867 to about 15 November 1872.)

The 1871 census (2 April) records Henry Broad at Yateley with his brother Lloyd, together with Elizabeth Piper an `Aunt', Martha Caute a `cousin', and Ishmael Gardner, `boarder, Schoolmaster, employed during Mr. Broad's illness'. Henry was still unwell.

On the 24 August 1871 Henry Broad (24) married Mary Ann Charlton (20) at St Paul's Covent Garden, Middlesex. Ernest Broad, Henry's brother, was a witness. Stephen Charlton, her father, was a Gardener. It's not certain where she hailed from, but one fairly local girl of that name found in the 1861 census, whose father was Stephen Charlton, was born at Hartley Wespall, 7.6 miles from Yateley.

School Log Book again - 12 January 1872, `...on Tuesday the Committee unanimously agreed that Mrs Broad should be Infant and Needlework mistress. Mrs Bunch left on Friday.' Mrs Bunch



was probably one of a number of visitors who muscled in and worked in the school. But Mrs Broad soon had her feet under the table! Was she living in the school house?

16 February 1872, 'Several children sent home having the whooping cough'

On the 31 August 1872, Mrs Broad gave birth to a son, Arthur Henry Broad, at Yateley in the County of Southampton. She was poorly after that as an entry in the Yateley School Log Book shows on the 9 September 1872, 'During Mrs Broad's illness, the girls will do lessons instead of needlework'. On the 9 October 1872 Mary Ann Broad registered the birth of her son.

The last entry in the Log Book by Henry Broad was on the 15

November 1872. No signing off, Henry's entries just stopped. On 30

December Henry Maidment took over as master of the school. Henry was seriously ill.
